Podcast Episode 49- Breast Cancer Awareness / Annual Enrollment October 23, 2025

Gina: Welcome to this week's Benefit Detective Podcast, I'm Gina.

Wendy: I'm Wendy. Well, Gina, it's October, and we all know October is Breast Cancer Awareness month.

Gina: Yes. It is.

Gina: Hey.... It's Dr. Lu! Perfect timing, Dr. Lu!

Dr. Lu: Hello. Thanks for having me.

Wendy: Well, it is October, which is Breast Cancer Awareness Month. So, Dr. Lu, why is it important to have a mammogram done?

Dr. Lu: Well, we get them done to screen for breast cancer. Screening tests in general are looking to detect diseases as early as possible since most conditions are easier to treat earlier in the course. By definition, a screening test is done when patients are asymptomatic, meaning they have no symptoms or complaints.

Wendy: And at what age should a woman get mammograms?

Dr. Lu: Well, this is difficult to say with certainty because medical recommendations often change, and the different organizations even have different recommendations. Currently, the recommendations have shifted back to most women starting at age 40 years old, but the starting age and the frequency of testing depends on each woman's risk factors, which should be discussed with the clinician. So, the answer is it depends.

Wendy: How often should a person get a mammogram done?

Dr. Lu: Well, twenty years ago when I trained to be a doctor, the recommendation was annually, but then they changed it to every two years for women at lower risk. But now the recommendations have shifted back again to one to two years depending on risk factors. So, ultimately, it's another case of shared decision making between the provider and the patient based on the patient's risk factors, family history, and even just personal preferences.

Gina: What steps can a person take to stay proactive on breast cancer?

Dr. Lu: Well, she should continue the annual well woman exams so that, she can discuss with a provider her individual case to see what testing is recommended. Please note that an annual well woman exam is different than the annual wellness exam, which most people refer to as their annual checkup. Both exams entail shared decision making regarding recommended screening tests, which is why we need adequate time to have those discussions by scheduling those visits separately.

Gina: Now, Dr. Lu, I hear that men can also develop breast cancer. Is that true?

Dr. Lu: Yes. They can, but not surprisingly, it's not as common as with women. But it is more common in men with strong family history of breast cancer, especially if it's in several women. In some cases, I've even heard of, families have multiple men with, breast cancer. So clearly, their risk is much higher and needs to be addressed earlier. And so, you know, again, that's just something they need to discuss with their medical providers and, on an individual basis And mention that to us, and we can figure out what would be a good time, and what is the best screening test for that male.

Gina: So, should men take the same proactive measures as women when it comes to breast cancer?

Dr. Lu: As we've discussed before, breast cancer in men is much less common. So, there is definitely not any universal screening recommended for men for breast cancer. And so it's, again, a condition where the males who think they're at higher risk should discuss that with their provider, and they can together decide through shared decision making what would be the best timing and test, for that particular patient.
