Podcast Episode 51 – Post Annual Enrollment & 6th Annual JBJ November 26, 2025

Gina: Welcome to this week's Benefit Detective Podcast, I'm Gina.

Gina: Yes, Sista friend! Yes!

Wendy: We have a few reminders. During annual enrollment, those with a spouse on the medical plan for 2026 needed to complete a spousal eligibility verification form. So, if it showed pending or secondary coverage, you'll need to turn in a certificate of credible coverage or proof of non-eligibility form, or an employer lay letter no later than 01/31/2026. And to find the form, you will go to eConnect, Risk Management forms, annual enrollment information, and then its 2026 certificate of credible coverage.

Gina: We did have some people that didn't do their spousal eligibility verification form during annual enrollment, and their spouses will be dropped off the medical plan starting as of 01/01/2026. Letters and emails will be sent out to those specific individuals. So, if you don't get any email or notification, then you're good. But there was only a handful.

Wendy: And if an employee sent in a new enrollment form to UNUM during annual enrollment and evidence of insurability emails were sent out by Gallagher. This is a timely link. If not completed by a certain deadline given, the link will close. So, check your emails, spam, and your junk emails.

Gina: New this year, we decided to see how many people reviewed or checked their annual enrollment packets. So, to make it somewhat fun, we changed it into a game. So, there were 10 people that completed the game piece, which was an annual enrollment bingo card that won, some special prizes when they turned it in before the deadline. So, thank you to those, and congratulations to those winners.

Gina: Also, make sure to check your phone numbers and addresses and workday to make sure that they are up to date. We are going to start processing and working on the 1095s in December. So, to avoid any delays, and this also goes for anybody who is going to be receiving new insurance cards. Make sure that you, check your addresses as well as your phone numbers in case we have to reach out to you. Make sure everything is up to date. Be sure not to delete any Social Security numbers that are currently in the system. It is very important to keep all of those there.

Gina: Any name changes, we'll need to match the Social Security number in case we have to reach out to you for a 1095 form question from the IRS. We wanna make sure that we can reach out to you via,

phone or via email. So just make sure that all of that is up to date. And in case anybody does not know what a ten ninety five form is, that is the insurance verification that is reported to the IRS every year. And sometimes people need that when they are going to do their income taxes.
